Narrative of Supplemental Report:

I was at the Lincoln Street Police Station at about 2122 hours when I heard the radio broadcast regarding the Officer Involved Shooting at 10th and Sedgwick and drove to the scene. I arrived at about 2134 hours and contacted the on-scene supervisor, Sergeant Toussaint.

I assisted Sergeant Toussaint by directing officers to establish an inner and outer perimeter around the scene with yellow crime scene tape. I further assisted with the overall supervision and management of resources at the scene. I remained at the crime scene until relieved by Lt. Graham at about 2355 hours at which time I drove Sergeant Toussaint to the Magnolia Street Police Station for his interview with the Detectives.
