62 Narrative of Supplemental Report On 09-13-13 at approximately 2130 hours, partner Officer Sears and I responded to the area on 10th St. east of Sedgwick Ave. to assist with a perimeter position. Shortly after arrival, we set up crime scene tape on the outer perimeter and conducted a canvass of the area in order to obtain statements. We responded to 2374 10th St. The residence was covered in a termite tent and no one was at the residence. We then contacted O1-Fuentes, Louis residing at [Redacted] I asked O1-Fuentes if he heard or saw anything. O1-Fuentes advised he was playing video games in his room (which is located on the southeast corner of the residence. As he was playing games, he said he heard what sounded like a gurgling coming from outside of his residence. I asked O1-Fuentes if he could describe the sound. He told me it sounded like fire crackers and said he did not think it was gunfire; because it did not sound like what he believed gun fire should sound like. O1-Fuentes checked other rooms in his residence and did not notice anything out of the ordinary; so he thought nothing else of the situation.
