Narrative:

On Friday, 09-13-13, at about 2108 hours, I was assigned to RPD's METRO/SWAT team. During this time, I heard over the radio that officers were involved in a shooting in the area of 10th St and Sedgwick Ave. Partner Officer Stennett and I responded to the scene to assist with canvassing the area.

I contacted the next door neighbor, at [REDACTED] Lopez. Lopez said he was inside his house watching a soccer match on television. He then suddenly heard what sounded like two firearms going off at the same time and several shots being fired. Lopez was not sure how many shots he heard.

Lopez's statement was recorded in detail using my department issued digital recorder.

I contacted the resident at [REDACTED] Bee. Bee said from inside his house he heard about 3-5 gunshots. Bee's wife, Diane, was watering the lawn and heard yelling followed by several gunshots. She could not make out what was being said or could advise how many shots she heard.

Bee's statement and his wife's statement were also both recorded in detail using my digital recorder.

After completing my canvass, I remained at the location as scene security until being released from the scene by Sgt. Warren on 09-14-13 at about 0005 hours.
