**Narrative:**

On September 13th, 2013, at about 2108 hours, Officer Macias (I.D. #1434) and I were assigned to the City of Riverside METRO Team. We learned through dispatch that an "Officer Involved Shooting" had occurred at 10th Street and Sedgewick Avenue. I responded to the incident to assist. Upon arrival I assisted with maintaining the perimeter of the scene during the investigation.

While on scene, I spoke to the residents of [REDACTED] O/Vasquez, Julie told me she was outside of her residence smoking when she heard someone yell, "Get down." She said she then heard five to six gun shots and nothing else. She did not see what happened.

O/Kaites, Leticia told me she was in the kitchen of her residence when she heard about six gunshots. She did not see or hear anything else.

O/Kaites, Santiago told me he was inside of his residence when he heard someone yell, "Get down." He then heard five to six gunshots. He told me he stayed inside. He did not see what occurred.

O/Vasquez, Len told me he was watching television and did not hear or see anything that occurred outside.

I recorded their statements on my Department Issued Audio recorder.

I remained on scene until I was relieved by Sgt. Warren at 09-14-13 at about 0005 hours.
