**NARRATIVE**

On Friday, September 13<sup>th</sup>, 2013 at approximately 2130 hours, I was notified of an Officer involved shooting which took place at 2395 10<sup>th</sup> Street in the city and county of Riverside. Personnel on-scene requested assistance from the RPD Gang Unit. I responded to the command post to assist.

While on-scene, I was directed to the front of the residence where Hector Jimenez's family and friends had gathered. We were attempting to locate the family member who had called 911. Detective Wood located the Reporting Party, Thalia Jimenez, who was with O1-Anavel Gomez.

**O1-ANAHEL GOMEZ'S STATEMENT**

O1-Gomez's statement was recorded using a department issued digital recorder. Below is a summary of her statement.

O1-Gomez is a friend of Thalia Jimenez. I asked O1-Gomez if she knew what was going on. O1-Gomez said she was not sure what happened since she has been staying down the street while her house is being fumigated. O1-Gomez said she got here about five minutes ago after receiving a phone call from Thalia Jimenez. O1-Gomez came to the Jimenez house and met with Thalia Jimenez and her family.

I asked O1-Gomez if she knew the S-Jimenez and the family. O1-Gomez said S-Jimenez has been drinking for years and been going in and out of the hospital. S-Jimenez currently has been having medical problems with his liver and pneumonia.

I asked O1-Gomez if she was aware of any problems the family had with Hector Jimenez. O1-Gomez said they would have conflicts here and there, but they usually arose when S-Jimenez was drinking.

**O2- JOEL NIEHUUS'S STATEMENT (AMR)**

I was then directed to contact AMR who was still on-scene. O2- Niehusuus' statement was recorded using a department issued digital recorder. Below is a summary of his statement.

O2-Neihuss is currently working on AMR Unit #354. Tonight they were dispatched and requested to stage in the area. O2-Neihuss said they staged on Victoria Avenue until it was safe to respond to the residence. When Dispatch advised it was safe they drove to the residence. O2-Neihuss said they got to the scene simultaneously with RFD. O2-Neihuss said they were then directed by RPD Officers to Hector Jimenez, who was in the front yard. O2-Neihuss said Hector Jimenez did not have a pulse, no signs of breathing and there was separation of the brain. Hector Jimenez was pronounced deceased at the scene by both RFD and AMR.

**Affiant's Declaration**

**TRAINING & EXPERIENCE**

I am currently employed as a Police Detective for the Riverside Police Department and have been a sworn peace officer since November 30<sup>th</sup>, 2000. I am currently assigned to the Gang Intelligence Unit in the Special Investigations Bureau as a Detective responsible for investigating gang crimes that directly affect community livability issues.

I graduated from the Law Enforcement Academy presented by the San Bernardino County Sheriff's Department, which included instruction in all areas of police work. I currently possess basic, intermediate and advance POST certificates. I also have obtained a Bachelor of Science degree in Business Administration / Political Science.

During my employment with the Riverside Police Department, I was assigned to the Patrol Division for over 7 years. Throughout my years in patrol, I worked the Casa Blanca, Hillside, Arlanza, La Sierra and Eastside neighborhoods. I regularly spoke with and interviewed numerous people who associated with gangs, believed to be suspected gang members or admitted gang members through field contacts, interviews and arrests.

In 2006, I attended the Field Training Officer Program presented by the San Jose Police Department. During this course, I learned how to successfully train new police officers who had recently completed the police academy. I was a field training officer for approximately 4 years and was responsible for training over 20 new officers in all aspects of police work. I taught each new officer how to speak with and interview people who were suspected of, or admitted to, committing thefts, burglary, possession of narcotics, crimes against persons and gang membership through field contacts, interviews and arrests.

In 2008, I was assigned as a Problem Oriented Policing (POP) Officer to the Central Neighborhood Policing Center (NPC). During this assignment I dealt with issues involving quality of life. I conducted follow-up on investigations, made arrests, conducted compliance checks on probationers and parolees, attended community meetings and reviewed current crime trends. Two of the major neighborhoods the Central NPC dealt with are the Casa Blanca and Hillside neighborhoods. As a POP Officer, I regularly attended community meetings including Casa Blanca Community Action Group (CAG) and Advisory Committee for Inter-Police Relations (AIR), to discuss current issues. A large number of complaints and concerns were regarding the gang activity in Casa Blanca.

In 2009, I was promoted to the rank of Detective. I was assigned to the North Neighborhood Policing Center. I was assigned to investigate property crimes and crimes against persons. During this time, I reviewed police reports and conducted follow-up investigations on a daily basis. I also reviewed crime statistics, interviewed witnesses and suspects, made arrests, and attended community meetings.

In March 2010, I was assigned to the Gang Intelligence Unit. On a daily basis, I meet with my colleagues in the Gang Unit to discuss current case trends, as well as review patrol officers' reports in which gang activity has been identified. I am in contact with criminal street gang members almost daily and continue to gain expertise and knowledge through these contacts.

I have attended over 600 additional hours in advance officer training. Some of the courses I have attended were:

I am currently a member of the Riverside County Gang Investigator's Association (RCGIA), California Gang Investigator's Association, and International Latino Gang Investigator's Association (ILGIA).

In the Fall of 2008, I responded to complaints expressed by the Casa Blanca community regarding on-going criminal activities. I prepared an operation to address these issues. During this operation, I conducted probation and parole compliance checks, gathered intelligence on the Casa Blanca gangs and made approximately 17 arrests.

In January 2010, I assisted the Riverside Police Department's Gang Unit and Riverside County District Attorney's Office with OPERATION PROMISE. OPERATION PROMISE targeted the on-going gang violence in the city's eastside neighborhood. During this operation, I conducted searches of several gang member residences and gathered gang intelligence.

In 2011, I was involved in Operation Tampa Bay. Operation Tampa Bay was an operation in which Confidential Reliable Informant(s) (CRIs) were used to develop gang intelligence, purchase narcotics and firearms. We used the CRIs to target the 1200 Blocc Crip gang members and its associates.

I have testified as a gang expert in Riverside County Superior Court.

**INVESTIGATION**

Detective Wood and I then responded to 2395 10<sup>th</sup> Street in the city and county of Riverside to assist with an officer involved shooting investigation. We then spoke to the on-scene supervisor, RPD Sergeant Gary Toussaint. Sergeant Toussaint said today (Friday, September 13<sup>th</sup>, 2013) at approximately 2120 hours, Riverside Police Department Dispatchers received a 911 call from 2395 10<sup>th</sup> Street in the city and county of Riverside, California. The Dispatchers spoke to an adult daughter who stated her father, Hector Jimenez (05-03-1963), was inside the residence cutting himself with a knife. The daughter was able to get her Father to go outside of the residence and she called the police.

Sgt. Toussaint said when RPD Officers arrived on scene, they were directed to Hector Jimenez, who was sitting on the south side of the residence on a wooden bench. Hector Jimenez was holding a large kitchen knife and began wiping his forehead with the knife blade. Jimenez began making motions with the knife appearing he was cutting his wrists and arms with the knife. Officers attempted to communicate with Jimenez to drop the knife so they could help. Jimenez ignored their commands and got out of his chair holding the knife. Jimenez then lunged towards the Officers with the knife. Officers fired their duty issued weapons at Jimenez. Jimenez was struck by the gun fire and stopped advancing towards the Officers and dropped the knife. The scene was secured by Officers and Medical Aid responded to the scene. Medical Aid pronounced Jimenez deceased.

Officers then conducted a safety sweep of the property and had all family members exit the residence.

RPD Detective J. Wood then spoke to Thalia Jimenez who identified the deceased subject as her father, Hector Jimenez (05-03-1963). Thalia said today her father was released from Parkview Hospital at around 1400 hours. When her father came home, he began drinking (alcohol) and taking his medication. Hector Jimenez became agitated and armed himself with a large kitchen knife. Hector Jimenez then began cutting himself multiple times with the knife, while inside the house with the family present. Thalia Jimenez was able to convince her father to go outside of the residence. Thalia Jimenez then called and requested the police.

During a walk through of the scene, Detectives noticed bullet strike marks to the exterior walls of the residence. A search would need to be done inside the residence to determine if the bullets had penetrated the exterior walls.

I respectfully request a search warrant be issued for the southern living quarters at 2395 10<sup>th</sup> Street in the city and county of Riverside, California.

I request that this warrant be endorsed for night service. Officers must collect and preserve physical evidence, if the family members are allowed back inside the residence, they may be able to tamper with and/or destroy any evidence. Officers currently have the residence contained and all occupants removed from the premises. Any delay of service would result in an unnecessary waste of time and expense. It

would be wasteful of police resources for them to maintain an all-night vigil of defendant's residence. This also inconveniences the family by not being able to enter and use their home. In this situation, the greater expectation of privacy sought to be protected by Penal Code section 1533 no longer exists, and thus it is no longer a reason not to search at night.

I also request that outside technical experts, including forensics technicians and evidence technicians be permitted to accompany searching officers at the discretion of the searching officers, during the service of the search warrant, for purposes of documenting and collecting evidence.
