I have attached the transcript for the original phone call made by S-1 Jimenez's daughter (Thalia Jimenez) and wife (Maria Jimenez) to RPD 911 dispatch. It should be noted that at the end of the conversation there is background conversation heard. The phone line remained open for a short period of time and a female was heard saying "Do you want us to get out, I'm gonna get out". There is also what appeared to be a police officer yelling "Put the knife down Hector" several times as the phone call ended.

54 You're calling from 2395 that's where he lives?

62 Q: Okay. Can I get your name?

64 A: Um, my name?

68 A: (Unintelligible) uh, Thali- Thalia.

70 Q: We won't tell him but I just need to know your name.

72 A: Thalia.

74 Q: Okay what's your dad's look like? He is Black, White or Hispanic?

78 Q: Is he Black, White or Hispanic?

116 A: He's uh, how old is he?

120 A: What do you mean? He's 50. What do you -- then how do you want me to  
121 talk? Scream and stuff? I'm not gonna scream. That's why I said you talk.

123 A1: Hello?

125 Q: Yes, uh, we're on the way right now. Um, what kind of knife does your dad  
126 have with him?

128 A1: Uh, this is his wife now. He has ah, uh, a kitchen knife.

130 Q: Is anybody out there with him right now?  
131  
132 A1: No, no.  
133  
134 Q: Or is he by himself?

136 A1: No. I tried to go outside and he said to get away from him.  
137  
138 Q: He still has the knife in his hand though right?  
139  
140 A1: Yeah, yeah.  
141  
142 Q: Your daughter was saying that he's sick? Like he has -- what is it?  
143  
144 A1: He- he has [REDACTED]  
145 [REDACTED] so he doesn't have nothing to live for and all  
146 this stuff.  
147  
148 Q: Has he ever tried to hurt himself before?  
149  
150 A1: Oh yeah.  
151  
152 Q: He's attempted to commit suicide before?  
153  
154 A1: Huh?  
155  
156 Q: Has he attempted suicide before?  
157  
158 A1: Yeah. No, don't -- that's okay.  
159  
160 Q: Is he- is he on any kind of medication or drugs right now?  
161  
162 A1: Uh, I don't know if he -- cause they gave him medicine today. They  
163 prescribed it but I don't know if he took anything.  
164  
165 A: (Unintelligible) tell the truth.  
166  
167 A1: Yeah well he takes all the pills that they gave him at the hospital. [REDACTED]  
168 [REDACTED] and he takes all that with  
169 beer.  
170  
171 Q: Okay. Is he violent right now?  
172  
173 A1: Huh?  
174  
175 Q: Is he violent right now?  
176  
177 A1: Eh, he's just sitting on the- on the chair on the bench outside like where the  
178 (unintelligible) poking himself in (unintelligible).  
179  
180 Q: He's sitting in a chair on the corner?

182 A1: Huh?  
183  
184 Q: He's sitting in a chair at the corner?  
185  
186 A1: He's sitting on the side of the house.  
187  
188 Q: But the side of the house is at the corner of 10th and Sedgwick right?  
189  
190 A1: Yes- yes. Uh-huh.  
191  
192 Q: And what is it doing with the knife?  
193  
194 A1: I'm not outside. I came inside. I'm -- he's like uh, swung the knife at me. So I  
195 came inside.  
196  
197 Q: He- he told you to get away from him or?  
198  
199 A1: Huh?  
200  
201 Q: He told you to get away from him?  
202  
203 A1: Yeah, he swung the knife at me and said, "Get away from me." He swung the  
204 knife at me.  
205  
206 Q: He swung it at you? He -- was he trying to hit you with it? He was swinging  
207 the knife at you telling you to get away?  
208  
209 A1: Yeah, he just -- I said wha- what -- I said, "Let me see." and he just swung the  
210 knife at me and said, "Get away."  
211  
212 Q: Okay. They're on there way right now. Let me just see where they are at. Hold  
213 on one second.  
214  
215 A1: Okay.  
216  
217 Q: You don't know where on his body he was cut?  
218  
219 A1: No. He had blood on his leg and on his pants. I don't know where else.  
220  
221 Q: Can you do me a favor? Can you- can you lock the front door to the house so  
222 that he does not go inside the house because the officer...  
223  
224 A1: Yeah, my door is locked.

226 Q: The door is locked?

234 Q: Okay we have an ambulance on the way for him also. They are gonna wait for  
235 the police to go approach him first and they should be there any second. Do  
236 you see the police outside at all? They're in the area. They should be there in  
237 in the area. Has he ever been violent with the police in the past or has he had  
238 any run-ins with the police in the past? That you're aware of? Oh my god  
239 they're yelling at him.
