4 **Source of Activity:**

5 On Friday September 13, 2013 at approximately 2145 hours, I was working in full
6 uniform, assigned as METRO-4 for the Riverside Police Department. While on duty I
7 responded to assist patrol officers reference an officer involved shooting that had just
8 taken place in the area of 10th St. / Sedgwick Ave. located in the city and county of
9 Riverside.

10
11 **Observations:**

12 Upon arrival, I noticed that several officers were already on-scene and a perimeter had
13 already been established with yellow police tape. I also noticed a crowd forming at the
14 above intersection. As I walked through the crowd in order to assist officer's on-scene, I
15 noticed two Hispanic males in the crowd that appeared to be agitated but I dismissed it as
16 on-lookers in the crowd. At the time I did not know who these two individuals were or
17 how they were involved in the incident.

18
19 Shortly after entering the scene, I noticed that one of the males (later ID'd as S-
20 started cursing towards the officer's who were inside the scene by stating "fuck
21 them, they can't keep us out". At this point I believed he was attempting to possibly incite
22 the crowd by causing a disturbance and entering the secured scene.

23
24 I focused on S- and noticed that he attempted to cross through the yellow crime
25 scene tape by attempting to walk underneath it and into the secured scene (violation of 148
26 P.C.). I then went to contact S- in order to place him into custody for the above
27 violation and advised him to turn around and place his hands behind his back. S-
28 refused by walking away from me and stating "fuck no, what for".

29
30 As I continued to walk towards him, he backed directly into Officer Macias who grabbed
31 S- right arm. I then grabbed his left arm in attempt of placing him into custody.
32 S- immediately stiffened up his arms and began to resist as I attempted to place his
33 left arm behind his back.

34
35 I then forced S- up against a parked police unit in order to gain better control of
36 him. S- continued to resist by keeping his left arm stiff and not complying with
37 my orders to place his hand behind his back. During this process, S- lost his
38 footing / balance and fell to the ground as he continued to resist.

1 I applied my body weight onto his upper torso as I lost my grasp of his left arm. I
2 immediately pinned the right side of his head directly onto the ground with my left
3 forearm in order to keep him down to the ground and regain control of his left arm.
4 Officer Macias assisted me in controlling S- [REDACTED] and gained control of both arms and
5 placed handcuffs on him. S- [REDACTED] was arrested without further incident and placed in
6 the back seat of a police unit.

7
8 During the investigation, I later learned that S- [REDACTED] was the son of the suspect who was
9 wounded during the officer involved shooting incident.

10
11 Based on the circumstances of the officer involved shooting, I was unable to establish
12 communication with S- [REDACTED] mother and instead contacted his adult brother
13 (O-De La Torre) who was explained the circumstances of S- [REDACTED] arrest.

14
15 O-De La Torre was further advised that a juvenile petition would be forwarded to the
16 juvenile court for filing and that his mother would be contacted by the courts at a later date
17 reference his arrest.

18
19 Due to the minor use of force, I took overall photographs of S- [REDACTED] in order to depict
20 any injuries. During the photo's I observed what appeared to be old injuries on his right
21 elbow and right knee. I asked him if those injuries were from today and he advised they
22 were old injuries. I then asked him if he had any complaints of pain and he pointed to the
23 right side of his head.

24
25 I inspected the right side of his head and observed redness directly above his right ear
26 which was caused from the head pin during the use of force. S- [REDACTED] refused medical
27 aid.

28
29 Prior to releasing S- [REDACTED], I asked him if he was present during the incident (officer
30 involved shooting) or if he saw anything. He stated that he was down the street and heard
31 several shots and then went to see what was going on.

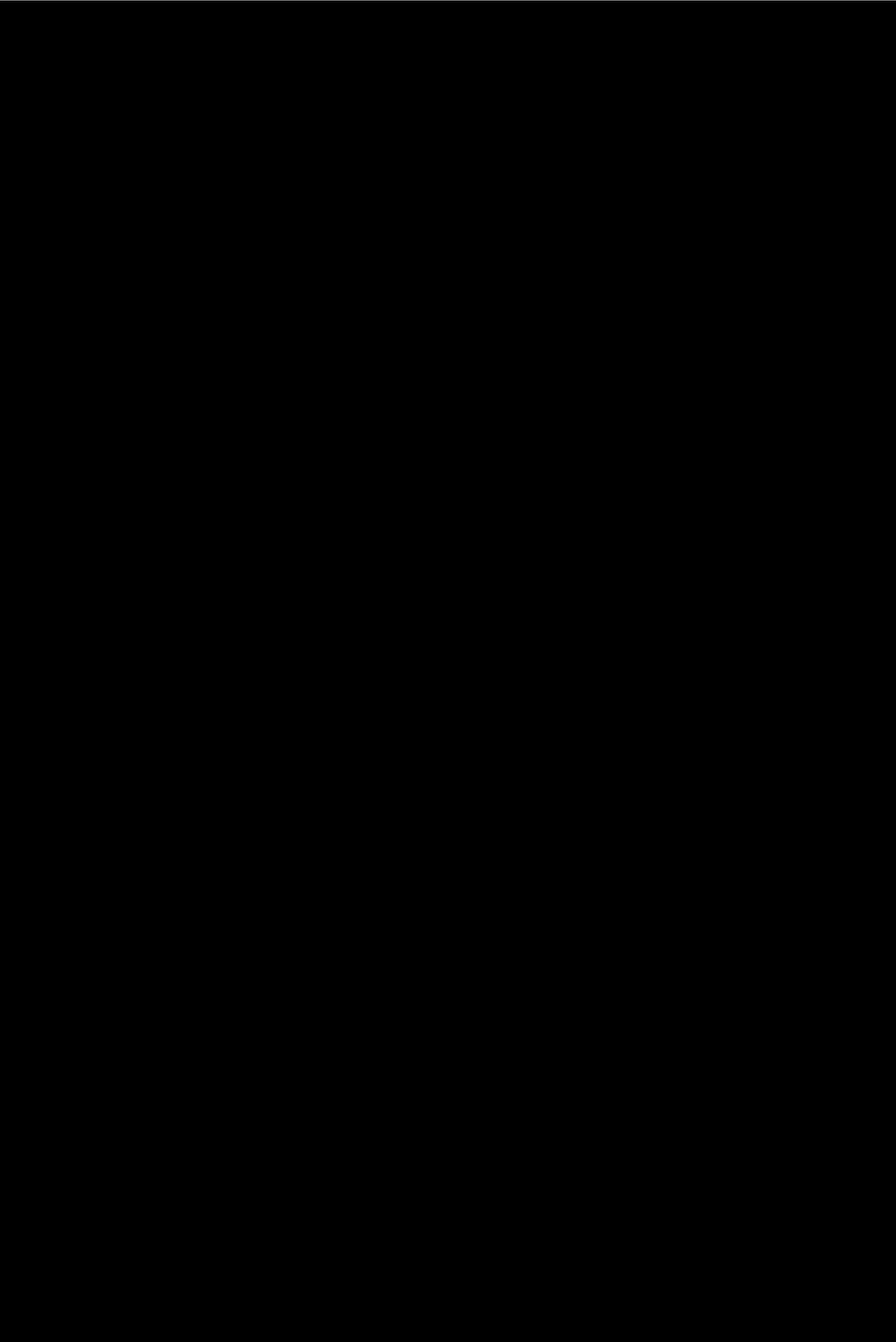

33 S- [REDACTED] was released to the care of O-De La Torre while on scene.

35 Sgt. Warren was on-scene and was advised of the use of force.
