1 **NARRATIVE:**

2 On 01/07/12, at approximately 1623 hours, I responded to 10745 Cypress Ave, reference a call of shots
3 fired. Upon arrival, I assisted in securing the scene and then contacted S/Ledezma's daughter
4 (W1/Yvette).

5 W1/Yvette stated at approximately 1530 hours, S/Ledezma and her mom (W2/Rebecca) returned to the
6 residence after attending a benefit car wash. While at the car wash, S/Ledezma's wife (W2/Rebecca)
7 learned that he had cheated on her. After arriving at the residence a physical altercation ensued where
8 S/Ledezma began hitting W2/Rebecca, prompting her to call police.

9 W1/Yvette said when police arrived on scene, S/Ledezma was at his car in the rear yard of the residence.
10 She followed behind officers as they went and contacted S/Ledezma. After being contacted by police,
11 W1/Yvette, said S/Ledezma had a knife to his throat and was threatening to kill himself. The officers on
12 scene gave him orders to drop the weapon, but S/Ledezma refused. After refusing to put down the knife,
13 W1/Yvette said S/Ledezma removed the knife from his throat and picked up a "stick" and began walking
14 towards the officers. When he started walking toward the officers, W1/Yvette said all three officers
15 tasered him.

16 During the interview, W1/Yvette started to get upset and said she was not going to "testify" against her
17 father (S/Ledezma). W1/Yvette had not talked to the investigating detectives yet, so I stopped my
18 interview to give her time to calm down, before speaking with detectives.
