On 01-07-12, about 1625 hours, partner Ofc. Serrato and I responded to a shots fired call involving police officers located at 10745 Cypress. Upon arrival and after the scene was secure, I contacted W/Serna located at [REDACTED] regarding what she knew of the incident.

STATEMENTS:

W/Serna was sitting on the porch to the front of her residence. She heard multiple popping sounds coming from the rear of the neighbor's yard located at 10745 Cypress. She heard a female screaming "Oh stop."

W/Serna heard male voices yelling, "Get on the ground" after the popping noise had ceased. W/Serna could only hear what was going on she could not see into the neighbor's yard because the chain link fence between her house and the neighbor's house is obstructed with a tarp like material covering the fence.
