7 On 1-7-12 at approximately 1625 hours, partner Officer Allison and I were dispatched to 10745 Cypress
8 Ave. regarding an officer involved shooting. We arrived at approximately 1634 hours and canvassed the
9 scene for witnesses. I located W/Castellanos standing to the front of [REDACTED] and he told me
10 the following: (recorded on digital audio recorder)

14 W/Castellanos said he was inside of his residence in the living room when his brother told him there
15 was a police unit parked outside of their residence. W/Castellanos exited the house and walked towards
16 the front yard. W/Castellanos was standing on his lawn when he suddenly heard approximately ten (10)
17 gunshots coming from 10745 Cypress Ave.

19 W/Castellano walked over to his pick-up truck that was parked in his driveway and he got on top of it to
20 see what was happening at 10745 Cypress Ave. When W/Castellano looked [REDACTED]
21 [REDACTED] he saw two or three females arguing with Officers.

23 W/Castellano said he walked inside his residence to get his baby and he walked back outside. By the
24 time W/Castellano walked back outside, there were several other officers and paramedics on scene.

26 W/Castellano said he did not hear or see anything else. He added that he did not hear anything prior to
27 the shots being fired.

29 We cleared the scene at 1655 hours to handle calls for service.
