**BACKGROUND: On 1-9-12 at approximately 0930 hours, I responded to 6116 Stover reference a supplemental report regarding the officer involved shooting(OIS) on 1-7-12. Upon arrival, I contacted RP/Martin who provided the following statement.**

**STATEMENTS: RP/Martin stated that he arrived to his residence on 1-7-12 at approximately 1630 hours and found a small hole in the exterior tinted glass of his upper oven. RP/Martin said that when he left his residence at approximately 1600 hours that day, the glass to that oven was not damaged. RP/Martin did not know what caused the damage. RP/Martin said he began to remove the damaged glass and discovered a bullet had come to rest between the exterior and interior glass. RP/Martin saw that there were dents in the sheet metal between the two panes of glass. RP/Martin began looking for additional holes in the kitchen for the entry point. RP/Martin discovered a hole in the window treatment above the sink. RP/Martin**

RP/Martin went outside and found the bullet had entered through the exterior kitchen window upper frame. RP/Martin collected the bullet and contacted police for assistance. RP/Martin said that he knew that there was a major incident on 1-7-12 and believed the bullet was a part of that incident.

NARRATIVE: I collected the bullet from RP/Martin and booked it into property at the Lincoln street station as evidence. I took photographs of the damage to RP/Martin's property. I photographed the bullet. No other damage was located.
