NARRATIVE:

On 01-07-12 at 1623 Hours, I was assigned to the Riverside Police Department Aviation Unit, flying helicopter N5074L. Officer Pelissero #275 was flying as pilot in the left seat and I was flying as Tactical Flight Officer (TFO) in the right seat. At the above listed time, we responded to 10745 Cypress Ave to assist an officer who advised 'shots fired.'
