1 **Narrative:**

2 On 02-23-15 at 2131 hours, Detective Williams and I responded to 2865 Prospect to assist with an officer involved shooting.
3 We arrived and found Officer Weddle and Detective Lackey to the front of that address. According to the radio traffic, the
4 suspect was outstanding and was armed with a shotgun. I also learned that the suspect had shot at the officers. Shortly after
5 our arrival, two male subjects arrived on foot and said that the suspect had committed suicide in their residence on Pleasant (the
6 two subjects were later interviewed by Detective Lackey). This information was relayed to dispatch and later confirmed by
7 assisting officers.

9 I also learned that the initial shooting had occurred to the rear of 2865 Prospect. I asked that the residents of 2865 Prospect exit
10 the residence. Detective Williams, Officer Mercadefe, Officer Wright, Officer Ortiz, Officer Herrington and I then conducted
11 a safety sweep of the residence.

13 Once the scene was secure, I directed officers to secure the scene by placing crime scene tape and maintaining a crime scene
14 log. I also assigned officers to obtain identifying information for each of the residents at 2865 Prospect and to conduct a
15 canvas of the neighboring houses for witnesses to the incident.
