62. Narrative of Supplemental Report

Background:

On 02/23/15 at approximately 2139 hours, I was at Orange Street Station when I heard Officers advised "Shots fired" in the area of Park Avenue and Pleasant Street. Ofc. Mowrey (who was also at the station) and I left the Orange Street Station and responded to the scene.

Investigation:

While Ofc. Mowrey and I were responding, dispatch advised the suspect was last seen running north from the area of Park Avenue and Pleasant Street and was armed with a long gun. Ofc. Mowrey and I responded to the area of Cottage Street and Grove Avenue to hold a perimeter position. While holding the perimeter position, an unknown Officer advised (via radio) residents at 2786 Pleasant Street advised the suspect entered the residence and was actively shooting. Ofc. Mowrey and I left our positions and responded to the location (one block west).
