On 02/23/15, Officer J. Elliott and I were working for the Riverside Police Department. We were conducting extra patrol in the area of the Riverside Municipal Auditorium reference a special event. At about 2140 hours, we heard an officer broadcast "shots fired" over the radio. We responded to Pleasant St. east of Park Ave. to assist. Upon arrival, O/Murray stated he saw a suspect run eastbound on Pleasant St. O/R. Valdez stated he heard a suspect run through his backyard at 2878 Pleasant St. towards the alley to the rear of his house. I maintained visual observations on 2878 Pleasant St. and maintained the perimeter at Pleasant St. and Park Ave. Officers updated there were no outstanding suspects.

O/R. Valdez stated on the evening of 02/23/15, he was inside his residence at [REDACTED] and he heard two males arguing and female voices trying to stop the argument. O/R. Valdez said it sounded like the voices were coming from one of the houses on the street (Prospect Ave.) behind his house. O/R. Valdez heard two gun shots that sounded like they came from a small pistol. A short while later, he heard the verbal argument start again. The argument got bigger. Then he heard someone running on the east side of his backyard and heard "cocking" noises and two loud booms that he thought came from a shotgun. O/R. Valdez said he did not see anyone and he stayed inside after he heard the gunshots.

O/P. Valdez stated she was inside her residence at [REDACTED] with her husband O/R. Valdez. She said she heard two loud shotgun booms, but did not see anything.

O/R. Valdez and O/P. Valdez consented to a search of their backyard. I conducted an article search of their backyard and observed there was what appeared to be blood on the grass near the fence leading to the alleyway.

I contacted O/Lopez and he stated on 02/23/15, around 1203 hours, he was inside the kitchen at residence, located at [REDACTED] when he heard banging noises like someone was knocking on his door. He looked outside and saw a police car pull up in the alley. O/L. Lopez stated he did not see anything. O/L. Lopez stated his wife O/E. Lopez and two children [REDACTED] were with him and did not see anything.

I attempted to contact the resident at 2864, but there was no answer and it did not appear anyone was home.

I contacted O/E. Salazar at [REDACTED] I observed there were four small holes in the front glass window near her front door. The holes appeared old. O/E. Salazar stated the four holes were from a BB gun and they were in the window when she purchased the house. O/E. Salazar stated on the evening of 02/23/15, she was sleeping and woke up when she heard police sirens. She brought her cat inside, but did not see anything. O/E. Salazar stated her husband O/M. Salazar and her two sons O/M. Salazar, Jr. and O/U. Salazar were inside the house with her. They did not see or hear anything unusual.

I contacted O/Murray and he told me on the evening of 02/23/15, he just returned home to [REDACTED] and was standing in his driveway with his guitar when he heard two gunshots, then one shot, then two more.

He heard a car drive away. He could not tell which direction the shots came from. He walked out closer to the street and heard two huge gun shots that sounded like they came from a shotgun from across the street. Then, he heard another shot that wasn't as loud. He saw a male run eastbound on Pleasant St. O/Murray described the male as a Black or Hispanic male, 5'11"-6'3", 190-250 lbs., with an athletic build, who was wearing baggy clothing with a red shirt and jeans. O/Murray stated he would not be able to identify the male if he saw him again. O/Murray said he did not see the male carrying a weapon. O/Murray said he saw a police officer chasing the male on foot.

I contacted O/D. Murillo at [REDACTED] and he said he was in his room watching television and did not see anything. O/Murillo said his parents O/J. Murillo and S. Murillo and his daughter O/[REDACTED] were also in the house, but they did not see anything.

I was relieved of my duties at 2400 hours and left the scene.
