3 **W/Lora Statement**

4 On 2/23/15, while standing to the front of 2786 Pleasant Ave. I made contact with W/Lora and took her
5 statement. W/Lora said she was at her residence located at [REDACTED] in the family room when
6 she saw "Steve" (family friend) inside the house. She was not sure who let him in but he was carrying a
7 shotgun and he was holding his butt and said "They got me." He was told to get out of the residence when
8 he was inside the bedroom. W/Lora said the family ran to the other side of the residence and she heard a
9 gunshot. W/Lora said the family then ran outside.

11 **W2/James DOE**

12 W2/James said on 2/23/15 he was at his residence located at [REDACTED] asleep in his bedroom.
13 W2/James said he was woken up by "Steve." "Steve" is a neighbor that lives down the street and their
14 kids play baseball together. He noticed "Steve" had what appeared to be a "long gun." "Steve" told him
15 Officers had got him and shot him twice in the butt. W2/James said he yelled at "Steve" to get out. He
16 then saw "Steve" pull the trigger twice on the gun but it didn't go off. The first time "Steve" pulled the
17 trigger, the gun was possibly pointed upward. The second time "Steve" pulled the trigger, W2/James said
18 "Steve" pointed the gun at himself but it didn't go off. W2/James said "Steve" then grabbed something,
19 possibly a bullet and put it in the gun. "Steve" then pointed the gun at his ("Steve's") chest/neck area.
20 W2/James said he ran out of the room and then he heard a gunshot.

22 **W3/Tajrah Statement**

23 W3/Tajrah said on 2/23/15 she was at her residence located at [REDACTED] asleep in her bedroom.
24 Her bed is located next to the front window. She was woken by the sound of two gunshots that she heard
25 from outside. She looked outside her window and saw "Steve" run near the garage and made entry into
26 their residence carrying a big gun. Once inside the residence, "Steve" ran into one of the bedrooms.
27 W3/Tajrah heard her Dad, W2/James, yell "get out!" W3/Tajrah heard a gunshot from inside the house
28 and she ran out the front door and called the police.
