On 02/23/15 at approximately 2310 hours, I was notified by Senior Forensic Technician T. Ellis to respond to 2865 Prospect Avenue to assist with an officer involved shooting investigation. I arrived at the location at approximately 0030 hours and met with Sr. Tech. Ellis. He requested that I respond to an additional scene at 2786 Pleasant Street and meet with Detective G. Rowe for briefing. I arrived at that location and met with Det. Rowe. I began my video of the scene at approximately 0123 hours. I then began taking my overall, medium and close-up photographs. With the assistance of Det. Rowe, I took measurements of S/ LEWIS, Steven and evidence items in the southernmost bedroom (see attached diagram). I then collected evidence items RL01 thru RL03, RL03A and RL03B (see attached Evidence Log and/ or Property Report for full item descriptions). I finished my assignment and left the location at approximately 0615 hours. I returned to the Magnolia Station and placed all evidence items into the evidence vault at approximately 0635 hours. I then downloaded (56) digital photographs into a secure file format (see attached Photo Log).

On 02/25/15 at approximately 1340 hours, I retrieved evidence item RL03: Maverick Mossberg shotgun for additional photographs. I finished my assignment and placed evidence item RL03 back into the evidence vault at approximately 1348 hours. I then downloaded (8) digital photographs into a secure file format.

On 02/26/15 at approximately 1115 hours, I retrieved all evidence items from the evidence vault for processing. I made (2) DVD copies of the scene video and labeled them evidence items RL00 and RL00A. I then released all evidence items to Police Property Specialist N. Jaggar at approximately 1318 hours.

No further action was taken.


