Narrative of Supplemental Report <b>On 11-18-14 about 1345Hrs, Detective Detmer, Eric briefed our unit (Riverside Police Department Special Investigation Bureau, Narcotics Team) that he had received information about S/Martinez being in possession of a quantity of illegal drugs and possibly a gun. Detective Detmer gained the assistance of the Police and Corrections Team to assist with a traffic stop of S/Martinez if he was seen leaving his residence at 5433 Bushnell Ave, Riverside CA. Detective Detmer advised that the suspect should be considered armed and dangerous as he was a prior felon with violence in his past. 3       Upon arrival at the location at about 1400Hrs S/Martinez's vehicle was not at the location  
4 and I initially set up at Grammercy Ave and Bushnell Ave. Due to the vehicle not being at the  
5 location I began searching the surrounding area for the suspect vehicle and S/Martinez.

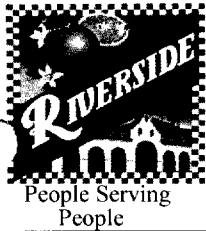

7       While conducting my search I heard via the radio that Detective Lomeli had located the  
8 suspect and the PAC Team Units were initiating the stop of the vehicle. The vehicle failed to  
9 yield as I continued towards the location. Prior to my arrival to the location officers broadcast  
10 "Shots Fired". Upon arrival at the location, I observed two Black Ford Explorer PAC Team  
11 Units with both with their engines running and all emergency lights on directly behind  
12 S/Martinez's vehicle (Gray Nissan Frontier PK, CA Lic # 70580R1). I assisted insuring the  
13 perimeter of the location was secure by searching the yards of 5431 and 5433 Bushnell Ave (two  
14 single family residence on one parcel of property with one house in front of the other). 5433  
15 Bushnell is the listed residence of S/Martinez and the location we were conducting surveillance  
16 for S/Martinez. Sgt Corbett Supervisor of the PAC Team later approached the vehicles and  
17 turned the emergency lights off.

19       While at the scene I was advised by Officer Sepulveda that the owner of the two  
20 residences O/Meier had arrived at the location and wanted to speak with a detective. O/Meier  
21 was very cooperative and advised that S/Martinez and his wife ("Tammy Luna") rent the rear  
22 residence of the location (3433 Bushnell Ave, Riverside CA). O/Meier said she knows that  
23 S/Martinez has access to weapons and has seen S/Martinez at the shooting range shooting  
24 handguns and long guns. O/Meier said S/Martinez has a key to both residences including the  
25 garage. I asked O/Meier for consent to search the residences and the garage as she advised that  
26 she has keys to both residences. O/Meier agreed and gave consent to searching the entire  
27 property. I returned a few moments later with Detective Lomeli and again asked her permission  
28 to search the property, which she said she did, though she also wanted us to get "Tammy Luna's"  
29 permission to search the rear property. I read the admonishment on the Consent to Search form  
30 to O/Meier and she signed the consent form. I informed O/Meier that even though she owns the  
31 entire premises we would still have to obtain "Tammy Luna's" permission to search since she  
32 has dominion and control of the location.

33  
34       After we received information that we had "Tammy Luna's" permission to search the  
35 location we conducted a safety sweep of both residences including the garage, which S/Martinez  
36 had an opener inside his vehicle that operated the garage door. I assisted with the search of the  
37 property (see Detective Detmer's report for details).

39       Upon completion of the search I returned both keys to the property to O/Meier and  
40 allowed her to return to the property.
