6 On Tuesday, November 18, 2014, I was working uniformed patrol in the City and County of Riverside,
7 CA. At approximately 1430 hours, I dispatched myself to the area of Bushnell Ave. and Keller Ave.
8 regarding officers from the Police and Corrections Team (PACT) pursuing a vehicle that was failing to
9 yield.

11 **Narrative:**

12 Upon arriving to the location, I was instructed by Sgt. Corbett to start a crime scene log to the front of
13 5431 Bushnell Ave. I maintained the crime scene log until I was relieved by Officer L. Doyle at
14 approximately 1545 hours.

16 After being relieved from the crime scene log, I contacted W/Joseph Martinez, who lives at [REDACTED]
17 Ave. The following is a summary of his statement:
18

19 At approximately 1430 hours, he was inside house walking toward the front door to walk outside, when
20 he heard sirens. As he exited out the front door of his house, he saw several uniformed police officers
21 running toward the back house (5433 Bushnell Ave.). As the officers were running he heard a male
22 officers voice shout, "Stop, stop." After him hearing the officer shout "Stop, stop", he heard
23 approximately six to seven gun shots.

25 He had no further information to add regarding the incident, at which time I ended my interview with him.
