1 **Narrative:**

2 On 11-18-14 at about 1430 hours, I responded to the area of Bushnell Av. and Keller Av. to assist the  
3 PACT team following a shots fired broadcast over the radio.

6 Upon arrival I was directed by Sergeant Cobb to park my vehicle about 4-5 houses east on Keller Av. and  
7 block west bound traffic. I placed my vehicle in the area as directed and provided peer support to Officer  
8 Arangure that was on scene at the time of the incident. Officer Arangure was standing to the front of  
9 10479 Keller Av.

11 I placed yellow crime scene tape at the open gate located on the west side of the residence located at  
12 10479 Keller Av. in order to establish an inner crime scene perimeter.

14 I then transported Officer Arangure to Magnolia Station to be interviewed.
