On 11/18/14, I interviewed Officer Cristina Arangure regarding the Officer Involved Shooting of Suspect Martinez. The interview was conducted at the Magnolia Station. The interview began at approximately 5:43 p.m. The interview was digitally recorded and later downloaded to the department server.

I told Officer Arangure that she was being interviewed as a witness in this case. She said she understood.

Officer Arangure said that she is currently a member of the PAC Team and her call sign is "Pac-10). She said she is partners with Officer Mercadefe. She said she was riding as the passenger with Officer Mercadefe. She was dressed in black BDU's and a black T-Shirt. She was also wearing a department issued tactical vest with "POLICE" in gold letters on the front and back.

Officer Arangure said that she was at the Magnolia Station when her team was assigned to work with the Narcotics Unit. Detectives from the Narcotics Unit asked her team to conduct a stop of a suspect who was dealing narcotics and was possibly armed. Her team was briefed at the gas pumps by Narcotics Detectives. Her team received a photograph of S-Martinez along with the make, model and license plate of his truck. Her team was also told that S-Martinez had a violent history.

Officer Arangure said that she and Officer Mercadefe parked their unit north of S-Martinez' residence. Officers Adcox and Ortiz (Pac-15) were parked south of S-Martinez' residence. She said that less than five minutes after they parked, she heard Narcotics Detectives on the radio say that they were behind S-Martinez' truck. She said they verified the license plate over the radio.

Officer Arangure said that Officer Adcox came over the radio and said that he and Ortiz were behind S-Martinez' truck. She said heard Adcox and Ortiz' siren on so she assumed S-Martinez was not stopping.

Officer Arangure said that her and Officer Mercadefe drove onto the street and saw S-Martinez driving towards them. She said she immediately recognized the vehicle as the suspect's. She said they were stopped at Bushnell Avenue when S-Martinez looked at them and turned south. She said Officers Adcox and Ortiz followed behind S-Martinez and she and Officer Mercadefe were behind them.

Officer Arangure said that S-Martinez turned left into a driveway. She assumed it was his driveway. She said S-Martinez sped up to the end of the driveway and then stopped. Officers Adcox and Ortiz immediately got out of their unit and began a felony stop. She saw S-Martinez get out of his car and stand there for a few seconds.

Officer Arangure said that she got out of their unit and was carrying the 40 Caliber Less Lethal rifle. She ran up to the passenger side of Officers Adcox and Ortiz' vehicle to assist. S-Martinez then started running away. Officers Adcox and Ortiz ran after S-Martinez and she followed them. She said she radioed that they were in foot pursuit of the suspect. She said S-Martinez ran down the side of the house and jumped over a three foot fence. She said Officers Adcox and Ortiz jumped over the fence, with Officer Mercadefe behind them. She followed Officer Mercadefe over the fence.

Officer Arangure said that just as she jumped over the fence, she heard six to eight gunshots. She said she was behind a garage and could not see the shooting. She said she did not know who was shooting, so she radioed, "Shots fired." She said her and Officer Mercadefe came around the garage and saw S-Martinez on the ground and Officers Adcox and Ortiz had their guns pointed at him. She said both Officers Adcox and Ortiz were yelling for S-Martinez to show them his hands. She said they repeated the command three times.

Officer Arangure said she was looking for the gun that S-Martinez had. Ortiz pointed to the gun that was about 20 to 25 feet away from S-Martinez. She said she stood over the gun until assisting officers arrived. She said Officer Adcox handcuffed S-Martinez.

Officer Arangure said that after S-Martinez was secured, she saw the owner of the house whose backyard they were in. She asked the owner to open her side gate and move her vehicle from the backyard. She asked these so medical personnel can enter the backyard.

I asked Officer Arangure if she heard any voices just prior to the shooting, and she said no.

Officer Arangure had no further information.

The interview was concluded.

Charting of Officer Arangure's handgun and ammunition

Evidence Technician Lane photographed Officer Arangure in her uniform that she was wearing at the time of the shooting. Lane then photographed and charted Officer Arangure's handgun and ammunition.

Officer Arangure carried a Glock 22 with serial number WDR004. The Glock had one (1) 40 S&W round in the chamber and fifteen (15) 40 S&W live rounds in the magazine. The magazine's capacity is fifteen (15) rounds.

Officer Arangure carried two (2) magazines in her magazine pouch. Each magazine had a capacity of fifteen (15) rounds. Both magazines were loaded with fifteen (15) rounds of 40 S&W in each.

Officer Arangure was also carrying a 40mm Less Lethal rifle with serial number D20748. There were three (3) live rounds in the side saddle and no rounds in the chamber.

All weapons and ammunition were returned to Officer Arangure.
