1 **Summary:**
2 On Tuesday May 10, 2011 at 1757 hrs., RPD officers were assigned to respond to 11532 Trailway Dr.
3 Riverside, CA for a report of shots being fired. Several reporting parties were stating that they had
4 heard multiple gunshots in the area.
5
6 Ofc. Fishell was assigned to respond to the call and drove to the area. He was the first officer on scene.
7 Ofc. Fishell approached the area on foot and saw a black male suspect (later ID'ed as S/Virgil Millon)
8 fire two gunshots at a female on the ground to the front of 11532 Trailway Dr. Ofc. Fishell engaged the
9 suspect with his duty weapon, striking him multiple times and ending the threat. Additional RPD
10 officers arrived and secured the area for responding investigators.
11
12 I was assigned as the case agent and Det. Cobb was assigned as the co-case agent. Detectives Simons
13 and Brandt oversaw the processing of the scene which included the interior and exterior of 11532
14 Trailway Dr. (V/Arabella Bradford's residence), the street to the front of the residence and 11531
15 Trailway Dr. (S/Virgil Millon's residence). Multiple bullet casings, bullet strikes, handguns and blood
16 stains were located inside and around 11532 Trailway Dr. and in the street. An additional handgun was
17 located in the front yard of 11531 Trailway Dr. Both V/Arabella Bradford and V/Malvin Conley were
18 located near the front of 11532 Trailway Dr., deceased.

20 Several witnesses were interviewed and assisted in putting together what happened, as well as, providing
21 a background history for this incident. Details regarding this investigation will be contained within
22 subsequent police reports.
