Scene Description/Observation:

11532 Trailway Dr. is located along the south side of the street, just west of Country Dale Dr.

Narrative:

On 05/10/11 at 1757 hours, I was dispatched to 11532 Trailway Dr.; reference an unknown trouble call. While en-route to the call, dispatch advised the RP had heard several shots and can hear someone screaming in the background. Dispatch further advised while on the phone with the RP, dispatch operator heard (4) additional shots and now the RP had locked herself in the bathroom with her 4 year-old son.

Upon arrival, I immediately heard 3-4 gunshots coming from a western direction. I exited the patrol unit, and ran along the houses located along the south side of Trailway Dr.; looking for Officer Fishell #1425 (first on-scene.) While approaching Officer Fishell's location (to the front of 11514 Trailway Dr,) I yelled out to him, "I'm with you, I'm with you." At this time, I asked Officer Fishell if he was "O.K." and he said, "Ya." I then asked Officer Fishell where the suspect was, and he motioned with his head in a north-west direction. I then looked across the street and saw a BMA, lying face down in the driveway of entrance of 11531 Trailway Dr.

I then told Officer Fishell that we had to check on S1's status and secure a possible firearm(s). I crossed the street and approached S1's location by running west along the north curb line of Trailway Dr.; using trees and cars as cover/concealment. Officer Fishell flanked by movement and approached S1 from south. As I got closer to S1, I realized he sustained a gunshot wound to the head (brain matter protruding from the skull.) I yelled to Officer Fishell that S1 was, "Done," and he (Officer Fishell) then yelled back to me saying we had victims to our left.

Officer Merrill arrived on-scene and I told her to, "cover down," on S1, and Officer Fishell and I ran over to the victims (lying to the front of 11540 Trailway Dr.) As Officer Fishell and I closed our distance on the victims (V1-BFA, V2-BMA,) I covered down on V2; who was lying face down with his hands underneath his body, and Officer Fishell made contact with V1. After a couple of seconds, Officer Fishell said to me, "She's still breathing," and we advised dispatch of V1 and V2's status.

Additional personal arrived on-scene and I was relieved by Officer Curtis #1265, and he took control (visually) of V2. I then assisted a team of officers, who were tasked with clearing the residence at 11532 Trailway Dr.; trying to locate the RP with her 4 year-old son.

Upon entry into the above stated address, Officer Goodson#106 and I located the RP and her 4 year-old son in a bathroom on the 1st floor; located in the south-west corner of the residence. I stayed in the bathroom with the RP and her son until the residence was deemed safe by the entry team. Once the residence was deemed safe, I escorted the RP and her 4 year-old son out of the residence and away from the immediate area. The RP and her 4 year-old son were escorted to Sgt. Banks location.

Once the scene was secure, I was escorted to Magnolia Station by Officer Munoz. While at the Magnolia Station, Det. Wheeler contacted me, and I advised him of what I saw/heard. Det. Wheeler stated a written report was sufficient.
