Narrative of Supplemental Report Source: On 05/10/11, at 1758 hours, while on uniform patrol in a marked black and white patrol car, I was at Magnolia Station assisting SACA Detectives with a unrelated investigation when I heard dispatch advise over my handheld radio a 246 PC just occurred on Trailway Dr. in the west NPC. I immediately went to my unit and began responding to the scene.											
Narrative: Enroute to the location I heard Officer Fishell advise "shots fired" over the radio. I responded code 3 to the location and arrived at about 1804 hours. I entered the location from Collett Ave. and parked my police car on Trailway Dr. facing west. As I exited my police car I saw an unknown male laying face down in a driveway, near the sidewalk on the North side of the street. I saw Officer Fishell kneeling beside an unknown

female on the opposite side (south side) of the street, about 1 house length west of the male. Sgt. Corbett directed me to escort Riverside Fire Department personnel to Officer Fishell's location which I did, using the south sidewalk of Trailway Dr. RFD personnel and I approached Officer Fishell and as I did this I saw a second unknown male lying face down in the grass, about 10 feet away and just south of where Officer Fishell was kneeling with the female. RFD began treating the unknown female and I escorted Officer Fishell away from the location.

I stayed with Officer Fishell at the scene for peer support. Officer Fishell was driven to Magnolia Station and I followed in my police car. I stayed at Magnolia Station with Officer Fishell until Detectives finished for the evening. I provided Officer Fishell a ride back to Lincoln Station.
