Source of Activity:

On 05-10-11, at about 1757 hours, Ofc. Goodson and I were working directed patrol in the North NPC area of the City of Riverside, when we heard a call go out over our unit radio, advising that multiple shots were being fired at a residence in the West NPC. We began heading in that direction as dispatch was updating the call, and advised that an adult female and juvenile were hiding inside the residence in a bathroom. They advised that there was an ex-boyfriend who was shooting at several people inside the house. Shortly thereafter we heard an officer "C410" advise that he was on scene and had been involved in an officer involved shooting and that there were multiple gunshot victims on scene. Knowing there was still people hiding in a residence and a very fluid and dangerous situation going on, we responded to the scene code-3 to assist.

Details:

Once on scene I was directed by Ofc. Castaneda to set up a perimeter on the southwest corner of 11531 Trailway and was told that was the suspects residence. As I did, I saw a black male laying in the driveway, who was face down and obviously suffering from a gun shot wound to the head. I could hear the male struggling to breath as he laid there. I also saw several people moving about inside of the residence, but was unable to see what they were doing. While maintaining the perimeter I heard over the radio, that Sgt. Corbett and a team of officers was making entry into 11532 Trailway to rescue the adult female and juvenile who were still hiding inside.

Once Sgt. Corbett's team rendered that residence safe and got everyone out safely, we called out all of the residents at 11531 Trailway. I then assisted the team with clearing 11531 Trailway and ensured there were no additional suspects.

Once back outside I saw two gun shot wound victims laying in the front yard of 11540 Trailway near Ofc. Curtis. I then assisted Officers Cash and Stennett by conducting a secondary search of 11532 Trailway, to ensure there were no additional persons hiding in the residence and no additional gun shot victims at the location.

I was later tasked by Sgt. McCoy to contact the neighbors and ensure they were safe and obtain pertinent statements. I went to [REDACTED] and spoke with a black male in his forties who identified himself as the homeowner. He did not wish to provide a formal statement but said he would be willing to tell me what he knew anonymously. He said the suspect (Virgil) has a long history of domestic violence with one of the victims, and they used to live together at 11532 Trailway. He said about a year ago, there was a domestic violence incident and S1 was arrested. As a result of his arrest, he lost his job with the Department of Corrections. Following his time in jail, he returned to the house but V1 would not take him back. V1 later took him to court and was awarded the house which they both owned. S1 then moved in with the neighbors directly across the street from his home (11531 Trailway). He said V1 and S1's relationship was very volatile and he believed it was only a matter of time before S1 killed V1. He also said about two weeks ago he told his wife that if she ever heard gunshots coming from that area to lay down real low and cover her head, because S1 was bound to kill V1 at some point. I asked him specifically about today and he said he heard about 30-35 gunshots and lots of screaming, but did not see anything. He said it sounded as though there were two separate guns being fired. When he finally looked outside, he saw S1 face down in his driveway.

I later went to 11540 Trailway and spoke with O1/Hopson and O2/Hopson. They told a similar story of V1 and S1's past, and furthered it by saying that V1 is a parole officer who is always armed with a .357 revolver. They said she often would talk about how she was never without her handgun because she is a parole officer and fears being retaliated against by parolees. O1/Hopson said following the breakup of V1 and S1, S1 moved in across the street with the neighbors. V1's boyfriend then began to frequent the house of V1, and it seemed to enrage S1. O1/Hopson said the boyfriend drove a BMW and whenever the BMW was outside the house he would see S1 (Virgil) outside just staring at the residence. On a few occasions he tried to strike up conversation with S1 when the boyfriend was at V1's house, but that S1 would stare past him as though he was not even there. He also feared that an event like today's was inevitable. He said on this date at about 1800 hours, he heard several gunshots and lots of screaming coming from the backyard of 11532 Trailway. He said he fell to the ground and told his son (O2/Hopson) to do the same. The two of them then low crawled to the west side of the residence until the shooting stopped. The estimated the total rounds expended to be about 25-30, and also felt there was more than one weapon being fired. O1/Hopson said at one point he saw S1 through a window in his front yard near his sons bedroom window, but did not know what he was doing. Neither of them actually saw the shooting, but only heard the chaos.

Following the interviews I maintained security at 11531 Trailway with Ofc. Goodson until we were relieved by Officers Skipper and Stucker, at about 2100 hours.
