When I arrived I could see a black male laying face down in the driveway at 11531 Trailway. I exited my patrol car and went to the front 11540 Trailway where there were two more subjects laying to the front of that location. Officers Fishell #1425 and Officer Mercadefe #1408 were standing in the street to the front of that location to the rear of a blue Dodge truck [Redacted]. I made my way to them. Victim(female) was laying on her left side partially on the sidewalk and partially in the street and under the passenger side of the truck.	COPIES TO
Victim(female) appeared to be deceased. Her head was facing South. Victim(Male) was laying face down in the front yard at 11540 Trailway. His right arm was under his upper chest. His head was facing in a Westerly direction. I handcuffed the male, due to the fact that radio had broadcasted that the suspect was a male black. The male and female were pronounced deceased by medical personnel a short time after my arrival. I maintained that portion of the crime scene until relieved at approximately 2300 hours.	VCL0 ()
