While I was enroute I heard a police unit broadcast "Shots fired!" I continued to the area in an attempt to assist other officers already onscene. Upon my arrival I took a position to the front of 11531 Trailway Dr. which was believed to be the suspects residence. I took a position with Ofcr. Brian Crawford to provide cover to officers searching another residence directly across the street. I observed people moving about the lower floor of the residence at 11531 Trailway Dr. and broadcast that information to other units. The subjects inside the residence at 11531 Trailway Dr. were ordered out of the residence and detained. Metro team members then searched the residence. I was then relieved by arriving investigators and cleared the scene at approximately 2050 hours.

Audio Recording Available? <u>No</u> On 05-10-11, at approximately 1757 hours, I was dispatched to assist other officers who had responded to 11532 Trailway, in regards to a call of subject who had been shot at the location. An officer involved shooting occurred after the first officers arrived at the location. Upon arriving at the location, I observed numerous officers who were preparing to make entry into a residence at 11531 Trailway after we received reports that other suspects were possibly still inside the residence. Ofc. D. Castenada requested that Ofc. T. Roy and I help move S-1 who was handcuffed and laying face down at the end of the driveway of the above listed address. We were to move S-1 so that he could receive medical attention from personnel from Riverside Fire Department and AMR. Medical personnel could not respond to where S-1 was due to the potential that other arrested suspects were still inside the residence. I took hold of S-1's left leg and foot. I then assisted Ofc. Roy with pulling S-1 approximately one-hundred feet to the east, and along the sidewalk where he was then medically treated. I then responded to the Magnolia Station with Ofc. Z. Fishell.
