On 05-10-11, at approx. 1900 hours, I was contacted by Sgt. Russell who notified me that there had been an Officer involved shooting. I responded to the Command Post at the corner of Trailway Drive and Countrydale Drive. Upon arrival to the scene, there was briefing being conducted. I participated on a walk through the crime scene.

I was assigned to assist I.D. technician Ellis with measuring and processing evidence along Trailway Drive. Trailway Drive is a paved asphalt roadway that is lined with street lights on both sides of the street. Trailway Drive is a small residential street with one speed hump within the crime scene. There are residential homes on the North and South side of the street. Items of evidence were located in several different areas throughout the street on the North and South side of the street.

Narrative Continued:

I.D. Tech Ellis and I began measuring and processing the scene at the location that Officer Fishell fired from (Front yard of 11514 Trailway Drive). This location is on the South side of Trailway Drive. Four silver colored .40 caliber shell casings were located in the grass area, just South of the sidewalk, in the front yard of 11514 Trailway Drive. All the shell casings were marked, measured and photographed where they were found.

We marked, photographed and measured two items of evidence in the driveway of 11523 Trailway Drive. This location is located on the North side of Trailway Drive, across the street from 11514 Trailway Drive. In the driveway we located a pair of handcuffs and blood evidence. This location is where S/Millon was dragged to a safe location after being shot in the driveway of 11531 Trailway Drive. 11523 Trailway Drive is one house East of S/Millon's residence. There was a blood trail from the driveway of 11531 Trailway Drive to the driveway of 11523 Trailway Drive.

We marked, photographed and measured two items of evidence at 11531 Trailway Drive. On the South portion of the driveway we found blood evidence. In the grass area, just West of the driveway we located a Ruger handgun. Parked in the street, to the front of 11531 Trailway Drive we located S/Millon's black truck. There was what appeared to be a bullet strike on the driver's side rear bumper that was marked, photographed and measured. Just behind (East of) the truck, we located what appeared to be a possible bullet strike on the concrete portion of the street/gutter that was marked, photographed and measured.

In the driveway of 11539 Trailway Drive, we located a projectile (bullet) and what appeared to be a bullet hole on the East portion of the garage door. Both items of evidence were marked, photographed and measured. We collected all items of evidence throughout out portion of the crime scene along Trailway Drive.

I then assisted I.D. Tech Lane with the backyard crime scene at 11532 Trailway Drive. On the West side of the residence, there is a wrought iron walk through gate. There is a concrete walkway that leads Southbound into the backyard. In the backyard there a concrete patio with a patio cover. The patio cover has several structural pedestals that hold up the patio cover. There was patio furniture, glass table and chairs on the patio. There are glass double doors (1 glass door had the glass shattered out) that lead into the residence, from the backyard, on the East end of the residence. There is a pool/spa with a concrete walkway around the back side of the pool/spa. There is a bar with bar stools, and a built in barbeque, on the East side of the backyard. The bar area is on a concrete slab that it raised above the concrete walkway around the pool. There was chicken and mushrooms on the barbeque, some that were cooked and some that had not yet been cooked along with food on the bar. There was a glass table and chairs on the concrete walkway along the East side of the pool.

I.D. Tech Lane and I located a black revolver, with a wooden handle, on the South side of the pool. Along with the handgun there was a piece of the wooden handle to the revolver that had been broken off the handle laying on the concrete walkway next to the revolver. All rounds in the revolver had been fired. Along the South side of the concrete walkway, along the South side of the pool, there is a planter that runs the entire length of the property. Inside the planter, just South of where the revolver was found, we located (4) silver colored 9MM casings. There was (1) silver colored 9MM shell casing found on the South edge of the concrete walkway in the same area that the four casings in the planter found.

Narrative Continued:

There was blood evidence located where the revolver was lying on the pool deck. We located blood evidence that went from the area where the revolver was found, around the East side of the pool, and continued in a Northern direction. There was blood evidence that led into the house and also a trail of blood evidence that led in a West direction along the North side of the pool leading to the West side of the house. The blood trail continued down the West side of the house in a Northern direction, leading into the front yard.

On the East side of the pool we located (3) 9MM shell casings, two casings on the concrete walkway on the East side of the pool and the other casing on the raised concrete portion around the bar. In the grass area, on the East side of the backyard, we located (1) silver 9MM casing and one projectile. We located what appeared to be bullet strikes on the stucco of the house, above the locations where the casing and projectile was located. We located three bullet strikes in the wooden fence that runs along the East property line of the residence.

We located a projectile, inside the pool, on the second step. A second projectile was located in the deep end of the pool, at the bottom of the pool. There was one live silver 9MM round located on the concrete walkway on the North side of the pool. We located several bullet strikes along the back of the house in the stucco and the bedroom window (window of the South/West downstairs bedroom). Along the back of the house we located several bullet fragments on the concrete patio.

All items of evidence in the backyard were marked, photographed and measured. Once all items of evidence were marked, photographed and measured, the evidence was recovered.
