Narrative of Supplemental Report:

On 6/6/2011, at 1105 hours, I arrived at 11532 Trailway Drive to verify my scene diagram from 5/10/11. I was approached by Ruth Stern (DOB: [REDACTED]) about a possible projectile. She identified the east front porch palm tree of 11532 Trailway Drive. I observed a possible fragment of the exterior front door in the palm tree. No projectile was located in or around the palm tree. I took (19) digital photographs of the palm tree and fragment. I conducted a metal detector search of the palm tree and surrounding area. No projectile was located. I collected the fragment, Evidence Item #SMD1. At 1216 hours, I cleared the scene and transported Item #SMD1 to the Magnolia Station. I secured the item in my locked evidence cabinet. I downloaded the photographs to a secure file format.

On 6/16/11, at 1529 hours, I released Item #SMD1 to Magnolia Station Police Property Specialist N. Jaggar. No further action was taken.
