2 I spoke to W/Martinez who told me the following.

4 W/Martinez said he was at a family party at 3055 La Cadena at approximately 2325 hours. He said he was
5 sitting outside in the front yard of the residence with several other subjects. He said he saw a cop car pull
6 up and shortly after heard a gunshot followed by two more gunshots. He said he looked up and saw a
7 subject standing near the Nissan Altima with what he believed to be a gun. He said he turned around and
8 ran inside.

10 I spoke to W/ [REDACTED] who told me the following.

12 W/ [REDACTED] said he was also at the party located at 3055 La Cadena at approximately 2325 hours. He said he
13 was in the front yard and saw a police car drive past. He said he then heard one or two gunshots and
14 looked up. He said he saw the officer jump over his hood and shoot back 2-3 times. He also saw S1 shoot
15 2-3 more rounds towards the officer.
