W/ [Redacted] saw a male subject standing outside of the front passenger of the vehicle's door and a subject sitting in the front driver's seat. W/ [Redacted] saw a Police vehicle driving South bound on E. La Cadena Dr. and flash his spot light towards the hicle when she saw the male standing outside of the vehicle start shooting towards the direction of the Police vehicle. W/ [Redacted] heard about three gunshots when she saw the Police Officer duck down behind his vehicle. W/ [Redacted] then ran inside of the residence to hide once she heard the gunshots.
