Narrative:

On 11-22-13 at about 2327 hours, I heard Officer Hunt broadcast that he was at First St and Vine St with a subject and shots had been fired. Responding from the area of Magnolia Av and Tequesquite Av, I activated my lights and sirens and drove toward that location to assist. I arrived on scene at about 2329 hours, and saw that other officers were already on scene. I saw a tan Nissan Altima 4D was stopped facing north bound at Poma Fuel, 3020 E La Cadena Dr, which is on the east side of E La Cadena Dr. I saw a police vehicle (later identified as Officer Hunt's patrol vehicle) was stopped in the middle of E La Cadena Dr facing south, and officers were taking cover on the west side of the police vehicle. I joined those officer's and waited for assisting personnel to respond.

Sgt. Wood advised that he needed someone to guide medical aid to a closer staging area. I directed RFD personnel to the area of First St and Vine St, and moved police vehicles out of the road way so as to create a clear path for paramedics. I returned to the scene as all three occupants of the tan Nissan Altima had been taken into custody. I saw that S1 was lying on the ground on the passenger side of the tan Nissan Altima.

I began to assist with the canvas of neighboring houses in an attempt to locate any witnesses to the incident.

I responded to 3055 E La Cadena Dr, where I made contact with a large group of juveniles and young adults, who stated they were outside in the front yard at the time of the incident. Other officers responded to this address to assist in obtaining statements.

I spoke with W/Galicia, Brandon (20 yrs). Following is a summary of the statement made by W/Galicia (recorded on my department issued digital audio recorder):

W/Galicia said he arrived at 3055 E La Cadena Dr at about 1830 hours for a Thanksgiving Day party. W/Galicia said he was outside on the patio of the residence at about 2330 hours, and a tan Nissan Altima was already stopped there. W/Galicia said he did not know that a police car was in the area. W/Galicia said he heard gunshots and he looked across the street and saw a subject (S1) standing by the front passenger door which was open. S1 was leaning over the roof of the vehicle, shooting a handgun in a westerly direction. W/Galicia said his view was obstructed by the patio, so he could not see what S1 was shooting at. W/Galicia said that now that he could see where Officer Hunt's police vehicle was located, S1 was shooting in the direction of Officer Hunt's police vehicle. W/Galicia said he heard about 3 or 4 shots, and he turn to run inside. W/Galicia did not see or hear anything further.

I spoke with W/ [REDACTED] Following is a summary of the statement made by W/ [REDACTED] (recorded on my department issued digital audio recorder):

W/ [REDACTED] said she arrived at 3055 E La Cadena Dr at about 2235 hours for a Thanksgiving dinner. W/ [REDACTED] said she was in the front yard of the residence talking with

1 friends when she saw a police vehicle pull up next to a tan vehicle that was stopped across the
2 street. W/ [REDACTED] said the driver of the tan vehicle (not further described) opened the driver door
3 and got out. W/ [REDACTED] said she heard gun shots coming from the area of the driver. W/ [REDACTED]
4 said she saw the police officer duck down. W/ [REDACTED] said she heard 3 shots fired. W/ [REDACTED]
5 then ran inside.
