I was contacted at my residence on 11-23-13 at 0130 hours by Det. Medici and advised of an Officer Involved Shooting that had just occurred. I responded to the RPD Magnolia Street Station to assist with the investigation. Upon arrival I was advised of the circumstances and assigned to interview W-Suarez. I met with W-1 Suarez on 11-23-13 at 0350 hours in interview room #1. I began the interview by obtaining W-1 Suarez's personal information. I then had W-Suarez explain to me what she observed while she (W-1) was at the scene of the Officer Involved Shooting.

W-1 Suarez advised that on 11-22-13 at approximately 2300 hours while walking on 10<sup>th</sup> St. near Kansas St. she (W-1) met up with S-1 Ramirez unexpectedly. W-Suarez said they talked briefly and then decided to walk to W-2 Estrada's residence on 10<sup>th</sup> St. W-Suarez stated S-1 Ramirez told her (W-1) that he (S-1) was going to ask W-2 Estrada for a ride. W-Suarez stated that upon arrival to the residence she (W-1) stayed outside to the front of the residence as S-1 entered W-2 Estrada's residence. W-Suarez said that S-1 was only inside for a short period of time and exited with W-2 Estrada. W-Suarez said that S-1 Ramirez had a beer in his hand and asked her (W-1) if she wanted to take a ride with them (S-1 and W-2). W-Suarez told me she agreed to go and got into the back seat of W-2 Estrada's vehicle (Altima Nissan). W-Suarez advised she sat behind S-1 nirez and stated W-2 Estrada then drove to the above location. W-1 Suarez said S-1 Ramirez directed W-2 Estrada to the location and he (S-1) exited upon arrival. W-1 Suarez stated she (W-1) isn't aware who S-1 Ramirez was visiting. W-1 Suarez advised she didn't know which house S-1 Ramirez went into. W-1 Suarez said at first W-2 Estrada parked on the same side of the street as the houses. W-1 Suarez added after approximately 5 minutes S-1 Ramirez came back to the car and told W-2 Estrada to park across the street as S-1 Ramirez went back towards the houses.

W-1 Suarez stated W-2 Estrada then drove his vehicle across the street into a parking lot as they waited for S-1 Ramirez. W-1 Suarez advised that after a few minutes the vehicle she (W-1) was seated in was being spotlighted from the front by what appeared to be a vehicle moving in their direction. W-1 Suarez said at this time she (W-1) observed that S-1 Ramirez had returned to the vehicle and had opened the front passenger door. W-1 Suarez stated she (W-1) then heard 4-5 gunshots and put her head down in her lap for safety. W-1 Suarez said she doesn't know who was doing the shooting but recognized that S-1 Ramirez had been shot. W-1 Suarez stated that she observed S-1 Ramirez partially inside the vehicle after the gunshots ended. W-1 Suarez advised S-1 Ramirez's (S-1) head was down on the front seat with his (S-1) lower torso outside of the vehicle.

W-1 Suarez stated because of the bright spotlight from the oncoming police vehicle she was unable to see anyone from inside the police vehicle. W-1 Suarez said a few minutes after the shooting she (W-1) along with

W-2 Estrada were ordered out of the vehicle and detained. W-1 Suarez explained that W-2 Estrada and S-1 Ramirez are acquaintances but not close friends. W-1 Suarez only knows W-2 Estrada as "Jose" and S-1 Ramirez as "Angel Boy" and "Smirks". W-1 Suarez advised she (W-1) had no idea that S-1 Ramirez was in possession of a handgun.

W-1 Suarez was very cooperative throughout the interview and gave consent to search her purse and cell phone. W-1 Suarez also gave consent for the collection of her DNA. W-1 Suarez was transported to her residence after the interview.
