Narrative of Supplemental Report:

I transported items TE-01 & TE-02 to the Magnolia St. Station for further processing and placed them into my locked evidence cabinet. On 11/26/13 at approx 1250 hrs, I removed items BE-01 thru BE-10 and TE-01 & TE-02 from my locked evidence cabinet and placed them into property via the Magnolia St. Station property lockers.
