Narrative of Supplemental Report:

On Wednesday, November 16, 2011, at 0737 hours I responded to 10406 Indiana Avenue to assist detectives that broadcasted "shots fired." Upon arrival I met with Lieutenant Phillips at the inner perimeter, east of the suspect's residence.

I called the resident, Mrs. Atkins [redacted] that lived in apartment #250, located directly above the suspect's home. She was alright. I told her I was making arrangements to relocate her across the upstairs walkway to her neighbor's home in #251.

I called the resident of #251, Mrs. Baker, [redacted] and confirmed that she was alright. I asked if she would let Mrs. Atkins stay with her in her apartment while we addressed the problem in apartment #242. Mrs. Baker agreed to let Mrs. Atkins stay with her.

Mrs. Baker and Mrs. Atkins only exit from their building was a stairway pass the suspect's front door so they could not safely leave the area. Mrs. Atkins vacated her apartment and was directed to stay with Mrs. Baker in the northwest portion of her apartment. The northwest location of Mrs. Baker's apartment was the furthest point from the suspect's residence and determined to be the safest area for them to be.

I was relieved from the scene once the Metro supervisors arrived.
