Narrative of Supplemental Report:

On 11/16/11 at approx 0955 hrs, I was contacted by Supervisor Fuller and told to respond to 10406 Indiana Ave. (Tyler Springs Apts for Seniors, Bldg Q Apt. 242) ref an OIS Investigation. Upon my arrival at approx 1012 hrs, I contacted Sgt. Amador and was assigned to take super 8 digital video (item TE-1) of the scene. I cleared at approx 1203 hrs, and Per Sgt. Amador, I responded to the Riverside Police Dept. Heliport to take aerial photographs of the apartment complex at 10406 Indiana Ave. Upon my arrival to the heliport at approx 1220 hrs, I took forty-two digital aerial photographs of the apartment complex and cleared at approx 1254 hrs. I responded back to 10406 Indiana Ave. to assisted I.D. Technician S. Lane with the processing of the residence. I completed a sketch (see attached Diagram) of the scene and cleared at approx 2013 hrs. I transported item TE-1 to the Magnolia St. Station for further processing and made a CD Copy (item TE-2) of item TE-1. I placed items TE-1 & TE-2 into my locked evidence cabinet. I then downloaded the digital photographs at the Magnolia St. Station Forensics Unit Office computer to a secured file format. On 11/22/11 at approx 1200 hrs, I removed items TE-1 & TE-2 from my locked evidence cabinet and placed them into property via the Magnolia St. Station property lockers.

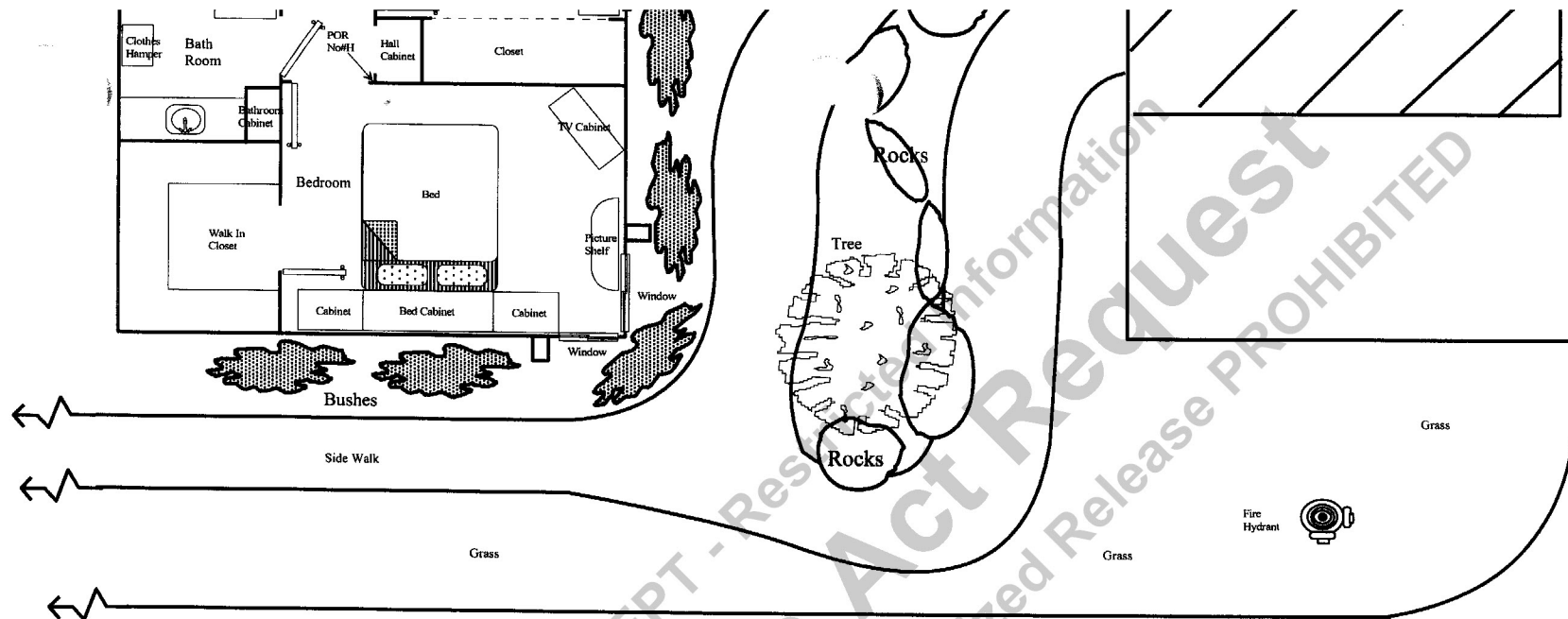

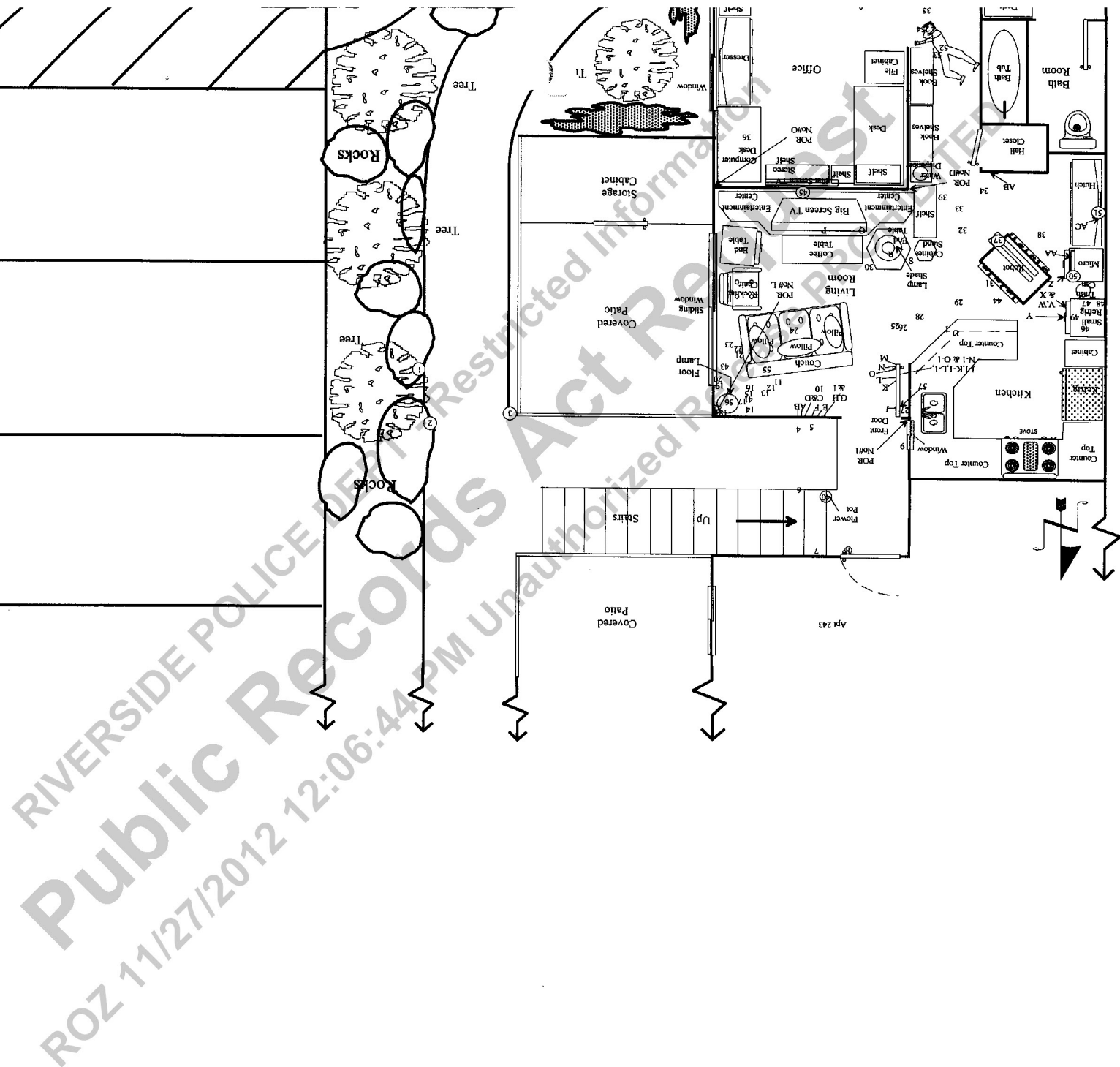
