I began taking my photographs at approximately 0911 hours (see attached Photo Log). I then received evidence items A01 through A10 from Forensic Technician J. Frisby N4450 at approximately 1201 hours (see attached Evidence Log and/ or Property Report for full item descriptions). I finished my assignment and left the location at approximately 1210 hours. I returned to the Magnolia Station at approximately 1245 hours and placed all evidence items into the Evidence Vault. At approximately 1455 hours, I retrieved all evidence items from the Evidence Vault for processing. I finished my assignment and released them to Police Property Specialist S. Robinson at approximately 1521 hours.
