**Source:**

On 10-14-12, at 0208 hours while on uniform patrol in a black and white police vehicle, in the City and County of Riverside, partner Officer Navar and I were dispatched to 3750 Myers Street#55 to assist with an officer involved shooting.

**Addresses Contacted:**

3750 Myers Street Apartments #30, #31, #37.

**Narrative:**

Upon arrival, I was instructed by Sergeant Stump to begin to collecting statements from surrounding apartment residents.

**Statements:**

I contacted the residents at apartment #30 and I received the following statements in summary: I spoke to W1/T. Macias who stated she was in her bedroom fixing her fan which sits in her window which faces apartment #55. She stated she heard what she thought was an argument and looked out her window and saw a male walk out. W1/Teresa could not see if the male was holding anything and then saw the officers shoot at him. W1/Teresa said approximately two weeks ago she called the police on this same male because he was beating up his mother. W1/Teresa was in her bedroom with her husband, O1/Cesar. W1/Teresa and O1/Cesar's daughters were also in the residence.

O1/Cesar stated he was in his bedroom with his wife. O1/Cesar did not see anything but heard several gun shots.

O2/ [REDACTED] W1 and O1's daughter, was in the kitchen when she heard gunshots and stated she ducked down to the ground and did not see anything.

O3/ [REDACTED] said she was in her bedroom and only heard the gunshots and did not see anything.

I went to Apartment #31 and spoke to O4/TeAlomia, O5/ [REDACTED], and O6/ [REDACTED]. I obtained the following statements in summary: O4/TeAlomia stated she was in her daughter's bedroom with her two daughters when she heard the officers saying, "we're here to help you". After that she stated she heard gunshots and got down on the ground. O4/TeAlomia did not see anything.

O5/ [REDACTED] stated she was in her bedroom with her sister and her mother. She heard gunshots and got down on the ground with her mother and sister. O5/ [REDACTED] did not see anything.

O6/ [REDACTED] said she was in her sister's bedroom when she heard gunshots. She did not see anything only heard the gunshots.

I went to apartment #37 and spoke to O7/Steigner and O8/Pignator and received the following statements in summary: O7/Steigner stated he was walking to the parking lot where his vehicle was parked when he heard approximately ten gunshots. O7/Steigner stated he did prior to the shots fired he heard what sounded like "loud arguing". O7/Steigner did not see anything.
