1 **Narrative:**

2 On 10-14-12 at approximately 2258 hours, I responded to 3750 Myers St, apartment #55, to assist with a
3 suicidal subject armed with a handgun inside his second story apartment.

4
5 Upon arrival, I was directed to take a position to the rear (west side) of the apartment to watch the second
6 story window of S1/Sherron's apartment. As I took my position on the west side of S1's apartment, I heard a
7 single gunshot that sounded like it came from S1's apartment. I then heard approximately 4-5 successive gun
8 shots coming from the same upstairs location. I ran up the stairwell to assist the officers on the upstairs
9 landing, believing they had just been fired upon by S1. I was advised to back down the stairwell due to cross
10 fire. I then heard an officer broadcast the suspect was down and in custody and all officers were OK.

12 I was then directed to assist in clearing S1's apartment for any other potential victims. AMR unit 356 and RFD
13 E-2 then arrived on scene to render aid to S1. I stood by as the RFD paramedic S. Seawright (ID# F562,
14 Paramedic #25593) pronounced S1 to be deceased. I later contacted dispatch to obtain the time of death
15 reported by RFD Paramedic Seawright and learned S1 was pronounced deceased at 2326 hours.

17 I then transported Officer Serrato to the Magnolia St Station and remained with him as a support officer until
18 relieved by assisting Peer Support Officers and Detectives.

20 I then cleared the call.
