On 10/14/12 at approximately 1120 hours, I was notified by Sergeant D. Russell to respond to 3750 Myers Street Riverside apartment #55 for an Officer involved shooting investigation. I arrived at the location at approximately 0040 hours and met with Sergeants D. Russell, D. Amador, C. Flores and K. Lambert, Detectives R. Cobb, R. Wheeler and M. Medici and Supervising Forensic Technician C. Fuller for briefing. Due to an impending automated sprinkler system, I began taking my overall, medium and close-up photographs of the courtyard at approximately 0105 hours. I then collected evidence items SL01, SL01A, SL02 and SL03. Next, I began videotaping the scene. I later labeled my scene video evidence item SL32. I then took my overall, medium and close-up photographs (see attached Photo Log). With the assistance of Det. Medici, I took measurements of the evidence items and possible strike marks A through E (see attached diagram). Next, I collected evidence items SL04 through SL20, SL24 and SL25. I then returned to the courtyard area and collected evidence items SL21, SL22, SL23 and SL26 (see attached Evidence Log and/ or Property Report for full item descriptions). I finished my assignment and left the location at approximately 0700 hours. I returned to the Magnolia Station at approximately 0705 hours and placed all evidence items into the Evidence Vault. I then downloaded (153) digital photographs into a secure file format.

On 10/16/12 at approximately 0935 hours, I retrieved my video camera and transferred the original digital video (SL32) from my video camera to a DVD. I then made a DVD video copy of the original DVD video of the scene. I labeled the DVD video copy evidence item SL32A. I then placed both evidence items back into the Evidence Vault at approximately 0950 hours.

On 10/17/12 at approximately 0755 hours, I retrieved evidence item SL11: Winchester 40 S&W cartridge from the Evidence Vault to take additional photographs. I finished my assignment and placed evidence item SL11 back into the Evidence Vault at approximately 0805 hours. I then downloaded (5) digital photographs into a secure file format.

At approximately 0910 hours, I was notified by Det. Medici to respond back to 3750 Myers Street for additional photographs and evidence collection. I arrived at the location at approximately 0920 hours and met with Det. Medici. I began taking my overall, medium and close-up photographs at approximately 0925 hours. Next, I took measurements of possible strike marks F through J and evidence items SL27 through SL31. I then collected evidence items SL27 through SL31 (see attached Evidence Log and or Property Report). I finished my assignment and left the location at approximately 1110 hours. I returned to the Magnolia Station and placed all evidence items into the Evidence Vault at approximately 1120 hours. I then downloaded (54) digital photographs into a secure file format (see attached Photo Log).

On 10/18/12 at approximately 1350 hours, I retrieved all evidence items from the Evidence Vault for processing. I finished my assignment and placed all evidence items into the Magnolia Station Evidence Locker #38 at approximately 1510 hours.

No further action was taken.


