Narrative

On Wednesday, November 16, 2011, I responded to the Tyler Springs Apartment Complex, 10406 Indiana Avenue, City and County of Riverside, to assist with an "11-99" request involving an Officer Involved Shooting.

Upon my arrival, Sgt. Dinco directed me to assist with the Command Post Operation. I was initially tasked to gather intelligence background on the suspect. After the crime scene was rendered safe, Sgt. Dinco directed me and other NPC detectives to canvass the apartment complex for witnesses. I was assigned to interview witnesses that reside in building "L."

I contacted and interviewed the following citizens there:

Blug, L, Apt. [REDACTED]

I interviewed O/Castro in her apartment. I showed Castro a photograph of the suspect and she told me she did not know him. She stated that an Officer came to her door this morning and told her to stay inside her

apartment and lock the doors. Castro said that she did not know the reason why she had to remain in her apartment. Castro also stated that she never saw or heard anything today that seemed unusual.

Bldg. L, Apt. [REDACTED]

I interviewed a married couple (W1/Edmundo Rebagay and O2/Rebecca Rebagay) there. Edmundo stated that he was eating breakfast this morning when he heard five gunshots. He looked out of the south window and observed several police officers running westbound toward Apartment building "Q."

Later, he looked through his peep hole and observed two officers knocking on his neighbor's apartment door [REDACTED]

The couple told me they remained in their apartment and observed the police activity from there.

I showed them a photograph of the suspect. They did not know the suspect and were not sure if they ever seen him before.

Bldg. L, Apt. [REDACTED]

I interviewed O/Catherine Williams-Keyes in her apartment. Catherine told me her friend (Jean) called her sometime after 0800 HRS. Catherine said that Jean asked her if she heard any shooting. Catherine stated that she did not see or hear anything because she was sleeping at the time. I showed Catherine a photograph of the suspect. Catherine told me she did not know the suspect and stated never seen him before.

Bldg. L, Apt. [REDACTED]

There was no answer at this apartment.
