Narrative of Supplemental Report:

On 11/16/11 at approximately 0950 hours, I was notified by Supervising Forensic Technician C. Fuller to respond to 10406 Indiana Avenue Bldg. Q #242 to process a scene for an officer involved shooting investigation. I arrived at the scene at approximately 1013 hours and met with Sergeants D. Amador and D. Russell, Detectives J. Brandt, R. Cobb, M. Medici, G. Rowe, R. Sanfilippo, J. Simons, D. Smith and R. Wheeler, Supervising Forensic Technician C. Fuller and Senior Forensic Technician T. Ellis for briefing. I began taking my overall, medium and close-up photographs of the entire scene at approximately 1114 hours. With the assistance of Det. Simons, I measured evidence items BL01 through BL09 and BL40 on the exterior of the residence. I then collected those evidence items and moved to the interior of the residence. I then collected evidence items BL10 through BL33, BL33A, BL34, BL35, BL36, BL36A, BL37, BL38, BL39 and BL41 through BL58 (see attached Evidence Log and/ or Property Report for full item descriptions). I finished my assignment and left the location at approximately 2030 hours. I returned to the Magnolia Station and placed all evidence items into the Evidence Vault at approximately 2035 hours. I then downloaded (391) digital photographs into a secure file format (see attached Photo Log).

On 11/18/11 at approximately 0900 hours, I retrieved all evidence items from the Evidence Vault for processing. I finished my assignment and released all evidence items to Police Property Specialist P. Trapp at approximately 1501 hours.

No further action was taken.
