Narrative of Supplemental Report:

On 3/01/2012, at approximately 0318 hours, I was called-out by Sgt. Lisa Williams, to respond to the above location to assist with processing the crime scene. I arrived at the scene at 0413 hours and received a synopsis of the incident from Lt. JB Brennan and Sgt. Keenan Lambert. I then started documenting the scene with digital video. I later made two DVD's of that video and labeled them CF-21 and CF-21A respectively. I took photographs of the scene and all of the evidence. Refer to attached Photo Logs. Detective Rick Cobb and James Brandt assisted me with identifying evidence items. Sr. Forensic Technician Selena McKay-Davis was called to the scene to assist with evidence recovery. We identified 20 evidence items and two strike marks at the crime scene. I completed two sketches at the crime scene. I collected all of the evidence items at that scene. Refer to attached Evidence Log and diagrams. I released evidence item CF-10 Motorola Black Boost Mobile cell phone to Detective Richard Wheeler at 1242 hours. I attempted to chart and clear evidence item CF-12: Taurus semi-auto pistol serial number [REDACTED] which was covered with dirt. The weapon was jammed and the slide could not be moved manually. Therefore, at 1002 hours, the weapon was released to Detective Jim Brandt to be taken to the Range Master to render the weapon safe. Refer to attached Weapons Charting Form. I then transported the remaining evidence items to the Magnolia Station. I retrieved evidence item CF-12 from the Forensic Evidence Unit Vault and I booked the evidence into the Property Lockers at 1500 hours. I downloaded the photographs to a secure file format. No further action was taken.
