SUBJECT: INVESTMENT SUMMARY AND FINANCIAL REPORTS - SEPTEMBER 30, 2012

ISSUE:

The item for City Council consideration is receipt of the monthly financial reports and an investment summary.

RECOMMENDATION:

That the City Council receive these reports.

BACKGROUND:

Sound investment practices are essential to good fiscal management. The Finance Director/Treasurer is responsible for managing the City's investment portfolio. Cash flow is monitored on a daily basis and unexpended cash is directed towards investments that exhibit first safety, then liquidity and an appropriate return on investment. The investment results are summarized and reported to the City Council at each month-end.

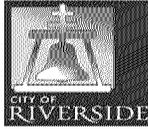
Sound management practices include monitoring revenue and expenditures against the City Council approved budget. Financial reporting is suspended pending the closing of the accounts for the fiscal year and completion of the independent audit.

There is no fiscal impact associated with this report.

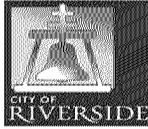

The Treasurer's cash management program and cash flow analysis indicates that sufficient liquidity is on hand to meet estimated future expenditures for a period of six months. The weighted average maturity of the pooled investment portfolio is 1.72 years. Market prices of securities are obtained from Interactive Data Corporation. Weighted average yield on cost is 1.180%.
