## ORDINANCE NO. 7626

**ORDINANCE OF** THE OF RIVERSIDE, AN LEVEL **ESTABLISHING** CALIFORNIA. COMPENSATION MAYOR AND PROVIDING OF THE AND REPEALING **FRINGE BENEFITS** CERTAIN ORDINANCE NO. 7278 IN ITS ENTIRETY.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Effective 30 days after adoption of this ordinance, and beginning with the first pay period thereafter, the Mayor shall receive compensation of *Seven Thousand Two Hundred Forty-Two Dollars* (\$7,242.00) per month. Said compensation shall be payable at the same time and manner as compensation of other officers and employees of the City.

Section 2: The Mayor shall receive those fringe benefits as are currently available to and have been established for the City Executive Management employees with the exception of sick leave and vacation accruals pursuant to the City's Fringe Benefits Resolution.

Section 3: Ordinance No. 7278 is hereby repealed.

Section 4: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside.

Section 5: This ordinance shall become effective on the 30<sup>th</sup> day after the date of its adoption.
