APPLICATION FOR YOUTH COURT VOLUNTEER

Riverside Youth Court has been developed as a part of the City of Riverside's Juvenile Justice System. **These are real cases**, where juveniles have admitted the misdemeanor offense, but have chosen to be judged by their peers in determining the consequences.

Youth Court is open to any youth, ages 12-17. Youth Court volunteer participants will learn about a respondent's offense and help select a suitable disposition designed to hold the youth accountable for his/her actions, and to encourage future compliance with the law.

As a volunteer juror, you will be able to participate in the program year round. Youth Court is held on the 2nd and 4th Wednesday of each month from 5:30 p.m. – 8:30 p.m. **The next volunteer training will be held on Saturday, November 8, 2014, from 9:00 a.m. - 3:00 p.m., at the Magnolia Police Station located at 10540 Magnolia Ave., Riverside, CA 92505.** Check-in will be at 8:30 a.m. Volunteers will receive 3 hours of community service for each youth court session they attend and 6 hours of community service for the training. You will need to bring this completed APPLICATION FOR YOUTH COURT VOLUNTEER form with you the day of the training. A parent's signature on this form is mandatory.
