The TREE POWER shade tree incentive program is open to Riverside Public Utilities ELECTRIC customers ONLY. Maximum of 5 shade trees per customer, per year. Complete program rules and guidelines at RiversidePublicUtilities.com.

While most trees are eligible for the program, due to the vulnerability of the City's citrus stock to Asian Citrus Psyllid and Huanglongbing (HLB), an agreement was made by RPU and the participating nurseries to remove any citrus trees from program participation.
